**Floyd County Board of Commissioners  
Ordinance Payment Policy for Certain Entities**

Whereas, the Floyd County Board of Commissioners met on March 1, 2016 on this matter pursuant to IC 6-3.5-7-12.7, 36-1-4-7, 36-2-6-2, 36-2-6-4, and 36-2-6-4.5;

Whereas, the Board of Commissioners have authority to enter into contracts and agreements including determining terms of payment pursuant to Indiana Code 36-1-4-7;

Whereas, the Board of Commissioners have authority over the EDIT funds pursuant to Indiana Code 6-3.5-7-12.7;

Whereas, the Board of Commissioners have the authority over the allowance and payment schedule of duly filed claims against the County pursuant to Indiana Code 36-2-6-4.5 (13);

Whereas, the Floyd County Auditor has stated a need for a policy regarding the payment schedules of the following entities with appropriations in the General, Riverboat and EDIT funds: Floyd County Solid Waste District, Life Springs Healthcare System (Community Mental Health Provider), New Albany-Floyd County Animal Control and Shelter, New Albany- Floyd County Building Authority, Rauch Industries, Inc. (Community Intellectual Disabilities Provider) and the YMCA of Southern Indiana;

Whereas, the Board of Commissioners hereby set the policy regarding payments for the following entities:

NOW, THEREFORE,

BE IT ORDAINED that Floyd County Board of Commissioners hereby directs and orders the Floyd County Auditor to pay duly submitted claims pursuant to Indiana code 36-2-6-4.5 for the aforementioned entities on the following payment schedules:

Floyd County Solid Waste District shall be paid its total (100 percent) of its annual appropriation based on the Board of Commissioners' authority over the EDIT funds pursuant to Indiana Code 6-3.5-7-12.7 no later January 10 of each year;

Life Springs Healthcare Systems (Community Mental Health Provider) pursuant to Indiana code 12-29-2 and prescribed in FCO-2015-9 shall be paid its annual appropriation as follows: fifty (50) percent of the appropriation shall be paid no later than June 1 of each year and fifty (50) percent of the appropriation shall be paid no later than December 1 of each year;

New Albany-Floyd County Animal Control and Shelter board shall be paid its total annual appropriation as follows: quarterly payment of twenty-five (25) percent of the annual appropriation shall be paid no later than January 15, April 15, July 15, and October 15 of each year.


New Albany-Floyd County Building Authority shall follow the payment schedule per its lease agreement dated March 28, 1959 which states semi-annual payments on January 1 and July 1 and attached as Exhibit A;

Rauch Industries, Inc. (Community Intellectual Disabilities Provider) pursuant to Indiana Code 12-29-1 and prescribed in FCO-2015-9 shall be paid its annual appropriation as follows: fifty (50) percent of the appropriation shall be paid no later than June 1 of each year and fifty (50) percent of the appropriation shall be paid no later than December 1 of each year;

New Albany Redevelopment Commission shall follow the payment schedule per the inter-local agreement for bond payments for the YMCA defined in Floyd County Council Ordinance 2006-2A states payment to be no later than January 10 of each year and attached as Exhibit B;
